ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a professional corporation under the Florida Professional Service Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE I

NAME

The name of the corporation is Lauren H. Patterson, Certified Public Accountant, P.A. at 331 Sullivan Street, Punta Gorda, Florida 33950.

ARTICLE II

CORPORATE PURPOSE

The general purposes for which the corporation is organized are:

1. To engage in the practice of accounting as a professional corporation and to carry on the services incidental thereto. The practice of accounting is the sole and exclusive professional service to be rendered by this corporation.
2. The purpose of this corporation shall be carried out only through its officers, employees, and agents, each of whom is duly licensed or otherwise legally authorized to render professional accounting services in the State of Florida.

ARTICLE III

CAPITALIZATION

The aggregate number of shares which this corporation is authorized to issue is five hundred, and such shares shall have a par value of \$1.00 per share.

ARTICLE IV

RESTRICTION ON TRANSFER OF STOCK

Stock of this corporation shall be issued and transferable only to natural persons duly licensed or otherwise legally authorized to render the specific professional service for which this corporation has been incorporated.

If, at any time, a majority or more of the shareholders of the corporation enter into an agreement between and among themselves and the corporation to restrict transfer of the stock of the corporation, the corporation shall thereafter refuse to recognize any transfer of stock of the corporation unless the same is in conformity with the terms and conditions of this agreement. The preceding sentence shall not apply unless a copy of such agreement is on file in the principal office of the corporation, and is noted conspicuously on the face or back of the certificates of stock. For purposes of this paragraph, the term "transfer" includes any sale, assignment or pledge of the stock of the corporation.

ARTICLE V

REGISTERED AGENT

The street address of the initial registered office of the corporation is 331 Sullivan Street, Punta Gorda, Florida 33950, and the name of its initial registered agent at such address is Lauren H. Patterson.

ARTICLE VI

MANAGEMENT OF CORPORATE AFFAIRS

The corporation shall have no board of directors, and all of the corporate powers shall be managed under the direction of the stockholders.

The stockholders shall have the right to determine in every instance the consideration for which the shares of the corporation shall be issued.

ARTICLE VII

ARTICLE VIII

BYLAWS

The power to make, alter, amend, and rescind the bylaws of the corporation shall be reserved to the stockholders of the corporation.

ARTICLE IX

AMENDMENT OF ARTICLES OF INCORPORATION

This corporation reserves the right to amend or repeal any provision contained in these articles of incorporation or any amendment thereto, and any right conferred upon the stockholders is subject to this reservation.

ARTICLE X

INDEMNIFICATION

The corporation shall indemnify any officer or former officer to the full extent permitted by the law.

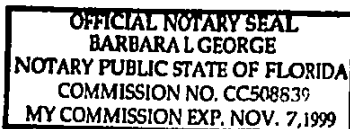


