**ARTICLE I

**ARTICLE II
TERM OF EXISTENCE**

The existence of the corporation shall begin upon the filing of the Articles by the Secretary of State and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III
PURPOSE**

The general purpose for which the corporation is organized to perform steel reinforcement services, and for any other purpose which corporations may be incorporated under Chapter 607 of the Florida Statutes and any amendments or successor statutes thereto.
