The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

**Article I**  
**Name**

**ARTICLE II**  
**DURATION**

The corporation shall have perpetual existence

**ARTICLE III**  
**PURPOSE**

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida


