ARTICLES OF INCORPORATION OF M.G.C. CORPPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is M.G.C. CORPORATION.

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE
