ARTICLES OF INCORPORATION

OF

S & K RESEARCH, INC.

ARTICLE I

CORPORATE NAME

The name of this corporation is: S & K Research, Inc.

ARTICLE II

NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is research, development and sales. The corporation shall have all powers afforded by the State of Florida.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

TERM OF EXISTENCE

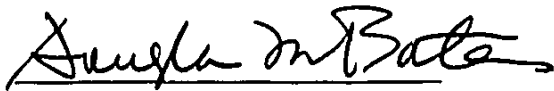
statement manifesting their intention that a certain amendment of these articles of incorporation be made.

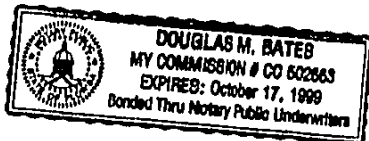
