ARTICLES OF INCORPORATION
OF

ARTICLE I - Name

The name of this corporation is AMERICAN POETRY AWARDS, INC.

ARTICLE II - Commencement of Existence

Commencement of corporate existence of the corporation shall be when the initial stated capital shall be paid in, which date shall be not later than ninety (90) days after the date of filing the Articles of Incorporation by the Department of State.
