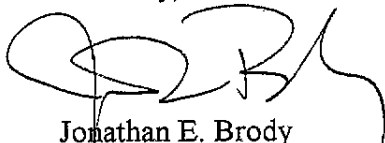

2. DATE OF INCORPORATION: The original Articles of Incorporation of the Corporation were filed on March 11, 1997 under document number P97000024119.

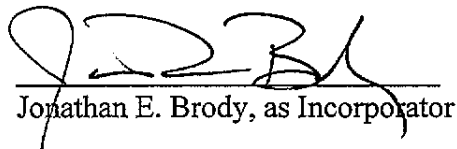
3. NO SHARES ISSUED: None of the Corporation's shares have been issued.
