ARTICLE I - NAME

The name of the corporation is ALL FLORIDA CARPET CLEANING, INC.

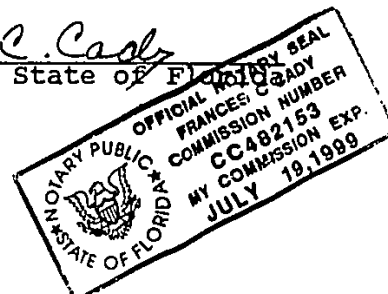

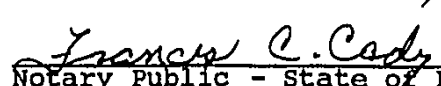
