ARTICLES OF INCORPORATION OF CAROLANN AUSTIN SWANSON, P.A.

The undersigned incorporator, for the purpose of forming a corporation inder the Florida Professional Service Corporation and Limited Liability Company Act, Florida Statutes §621, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be CAROLANN AUSTIN SWANSON, P.A.

ARTICLE II CORPORATE DURATION

The period of the corporation's duration is perpetual.

ARTICLE III PURPOSES

The corporation is organized for the sole and specific purpose of rendering professional legal services to the general public by and through attorneys at law duly licensed by the State of Florida to practice law.

ARTICLE IV CAPITALIZATION
