ARTICLES OF INCORPORATION

OF

YBYIK Incorporated

The undersigned, acting as sole incorporator of **YBYIK Incorporated**, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

ARTICLES V




