ARTICLES OF INCORPORATION OF A.S. SPORTSWEAR, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Figirida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be A.S. Sportswear, Inc..

ARTICLE II

The corporation shall have the power to engage in any lawful activity for which corporations may by organized under the Florida Business Corporation Act.

ARTICLE III
