**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF  
AQUATIC SUBSURFACE INJECTION SYSTEMS, INC.**

Pursuant to the provisions of Section 607.1006(1) of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

2. The following amendments to the Articles of Incorporation were adopted by the Shareholders of the Corporation on the 11 day of January, 2002, in the manner prescribed by the Florida Business Corporation Act:
