**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
SEAGRASS RECOVERY, INC.**

Pursuant to Section 607.1006 of the Florida Statutes, the Articles of Incorporation of SEAGRASS RECOVERY, INC., a Florida corporation (the "Corporation"), are hereby amended as follows:

1. The name of the Corporation is SEAGRASS RECOVERY, INC. The document number is P97000024262.

2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

The name of the corporation is:


SR Liquidating, Inc."
