The undersigned subscriber as to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida

ARTICLE I--NAME

In furtherance, and not in limitation of the general powers conferred by the laws of the State of Florida and of the purpose and objects hereinabove stated, this corporation shall have all and singular the following powers:

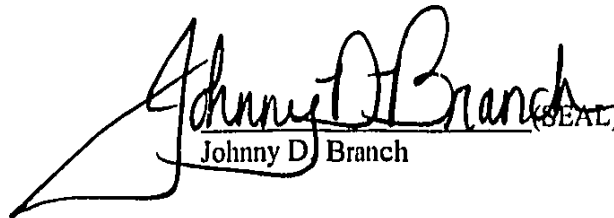
This corporation shall have the power to enter into or become a partner in, any arrangement for sharing profits, union of interest, or cooperation, joint venture or otherwise, with any person, firm, or corporation to carry on any business which this corporation has the direct or incidental authority to pursue.

This corporation shall have the power to deny to the holders of the common stock of this corporation any pre-emptive right to purchase or subscribe to any new issues of any type of stock of this corporation, and no shareholders shall have any pre-emptive right to subscribe to any such stock.

This corporation shall have the power to, at its option, purchase and acquire any or all of its shares owned and held by any such shareholders as should desire to sell, transfer or otherwise dispose of his shares, in accordance with the by-laws adopted by the shareholders of this corporation setting forth the terms and conditions of such purchase; provided, however, the capital of this corporation is not impaired.

This corporation shall have the power to enter into, for the benefit of its employees, one or more of the following: (1) a pension plan, (2) a profit-sharing plan, (3) a stock bonus plan, (4) a thrift and savings plan, (5) a restricted stock option plan, (6) other retirement or incentive compensation plans.

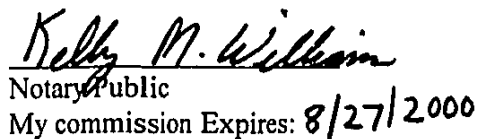
