ARTICLES OF INCORPORATION OF RDT DEVELOPMENT, INC.

I, the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation under and by virtue of the laws of the State of Florida under the following proposed charter:

ARTICLE I - NAME/ADDRESS

The name of this corporation shall be RDT Development, Inc. and its business shall be carried on in the State of Florida and such other states and countries as may be agreed upon, and its principal place of business shall be 1812 Weatherstone Drive, Safety Harbor, Florida 34695 or such other place as from time to time is designated.

ARTICLE IL - PURPOSE

This corporation shall be authorized and permitted to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK
