Dear Sir or Madam:

Please be advised that I am the attorney for the Personal Representative of the Estate of Paul J. Ruby. Paul died unexpectedly on February 7 of this year and left behind a massive amount of paperwork. In this regard, Paul was the sole shareholder and sole officer of Ruby & Donovan, P.A., and in going through all of Paul's paperwork, Paul's Personal Representative recently came across the 2001 Uniform Business Report which is appended hereto. The Personal Representative was of the belief that Paul had timely filed his UBR but obviously, this was not done.

Based upon the recent discovery by the Personal Representative of the non-filing as a result of Paul's untimely death, I respectfully request that the Division of Corporations waive the \$400 late charge which would otherwise be imposed for a willful non-filing.

In closing, I have appended a check which has been drawn in favor of the Florida Department of State in the amount of \$150 which represents payment of the annual filing fee.
