
ARTICLE VII - CUMULATIVE VOTING

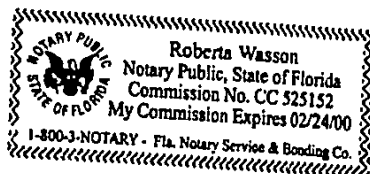

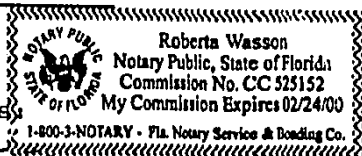
