ARTICLES OF INCORPORATION
OF

AFFIRMATIVE TITLE, INC.

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

AFFIRMATIVE TITLE, INC.

The name of the corporation shall be Affirmative Title, Inc.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
