ARTICLES OF INCORPORATION OF

CALADIUM CARPET INC.

The undersigned subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE 1._- NAME_

The name of this corporation is:

CALADIUM CARPET INC.

ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in all aspects of sales, retail, wholesale and for export of residential and commercial carpet and related products of padding and tile including installation and delivery and to engage in any and all functions, services and/or activities related necessary incidential, proper and/or ancillary thereto and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
 - (b) To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description.
