

ARTICLES OF INCORPORATION



ARTICLE I - NAME

The name of this corporation is Prime American Insurance Agency, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 2620 North Andrews Avenue Fort Lauderdale, Florida 33313

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
