# ARTICLES OF INCORPORATION OF DAVID S. SIMON, P.A.

The undersigned natural persons, each of whom is licensed or otherwise legally authorized to practice the profession of law in the State of Florida, hereby associate themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopt the following articles of incorporation for such corporation:

# ARTICLE I

The name of the corporation is DAVID S. SIMON, P.A.

## **ARTICLE II**

The period of the corporation's duration shall be perpetual or until dissolved a vote of the shareholders as hereafter provided.

## ARTICLE III

This corporation is organized for the following purposes:

- a. To engage in the practice of law as a professional law corporation and to carry on services incident thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- c. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar of, and is duly authorized to practice law in, the State of Florida.

#### ARTICLE IV

The total number of shares of capital stock which the corporation shall be authorized to issue is one hundred shares. Such shares shall be of a single class and have no par value.

#### ARTICLE V

The address of the corporation's principal office is 523 South Washington Blvd., Sarasota, Florida 34236. The name of the initial registered agent of the corporation located at such office is David S. Simon.

#### **ARTICLE VI**

The corporation shall have all the rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida.

# **ARTICLE VIII**

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is one, and the name and address of the initial director is:

David S. Simon

The initial directors shall hold office until their successors are elected and qualify as provided in the bylaws. Thereafter the term of office of each director shall be perpetual until the election and qualification of a successor. The number of directors set forth herein and constituting the initial board of directors shall be the authorized number of directors until such number is changed by a bylaw duly adopted by the shareholders.

# **ARTICLE IX**

The initial director shall submit the proposed bylaws to the shareholders at a meeting to the be held for that purpose not more than thirty days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by affirmative vote of all shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with such bylaws.

# **ARTICLE X**

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least fifty-one percent of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.
