

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is GLOBAL UNITED TRADING, INC..

ARTICLE II.

The main location where the company shall conduct its business is 2626 Clear Court, Jacksonville, Florida 32207.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100) shares of common stock with a par value of Five Dollars (\$5.00) per share.



The name and address of the sole incorporator is KSHITIJ J. SHUKLA, 488 Filmore Drive, Jacksonville, Florida 32225.


