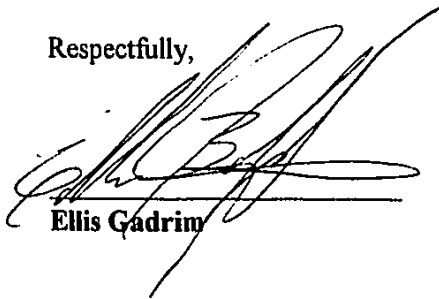

ARTICLE ONE

The name of the corporation is **PRO-POLISH DETAILERS, INC.** The principal address of the corporation is: 8020 Cleary Boulevard, #213, Plantation, FL 33324.

The period of its duration is perpetual.

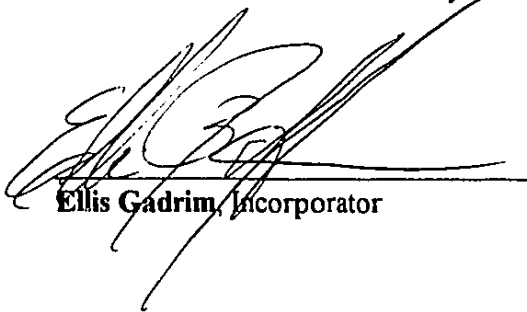
ARTICLE EIGHT
