ARTICLE I

Name

The name of the corporation is: JOY AND LOVE, INC.

ARTICLE II

Term of Existence

The date when corporation existence shall commence shall be the date of the filing of these articles of incorporation by the offices of the Florida Department of State and the Corporation shall have perpetual existence thereafter

ARTICLE III

Nature of Business

The Corporation is organized to engage in every aspect of the business of producing, selling, marketing artwork, including but limited to greeting cards, stationery, clothing, fabrics, linen and any other business permitted by law.

ARTICLE IV

Capital Stock

These articles of incorporation may be amended in the manner provided by law.




