

ARTICLES OF INCORPORATION
OF
TRAVIS H. TRUE, INCORPORATED

I, the undersigned, make, subscribed, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purposes of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be: Travis H. True, Incorporated.

ARTICLE II

PURPOSE

The general purpose or purposes for which the corporation is initially organized shall include the transaction of any and all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statutes, 1995.

ARTICLE III

EXISTENCE OF CORPORATION

The corporation shall begin existence on filing of these Articles and shall have perpetual existence.

ARTICLE IV

CAPITAL STOCK

A. The total number of shares of capital stock authorized to

be used by the corporation shall be seven thousand (7,000) shares having a par value of One Dollar (\$1.00) per share. Each of said shares of stock shall entitle the holder thereof to one vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor or services at a fair evaluation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.

B. In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE VI

INITIAL BOARD OF DIRECTORS

The number of directors constituting the initial board of directors shall be one and the name and address of the person who is to serve as the member thereof is as follows:

PRINCIPAL OFFICE

ARTICLE IX

PREEMPTIVE RIGHTS

The holder of the stock of this corporation shall have the preemptive right to subscribe for and purchase their proportionate share of any additional stock issued by the corporation from and after the issuance of the shares originally subscribed for by the stockholders of this corporation, whether such addition shares be issued for cash, property, services or any other consideration, and whether or not such shares be presently authorized or be authorized by subsequent amendment to these Articles of Incorporation.

ARTICLE X

AMENDMENT TO ARTICLES OF INCORPORATION

The corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute and all rights conferred upon the stockholders herein are subject to this reservation.
