ARTICLE I.

NAME

The name of this corporation is North Florida Business Solutions, Inc.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

COMMENCEMENT OF EXISTENCE

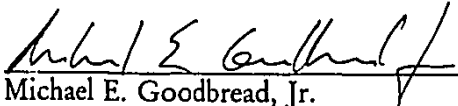
