ARTICLES OF INCORPORATION

OF

COOL RECOVERY INC.



The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation (hereinafter called the "corporation") is Cool Recovery Inc. The mailing address and principal place of business of the corporation shall be 3650 Palm Drive, Riviera Beach, FL 33404.
