ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I Name

The name of this corporation is, FLORIDA WEST COAST RENTALS INC., whose mailing address is 116 Pinellas Bayway, Tierra Verde, Florida 33715.

ARTICLE II Principal Place of Business

This corporation's principal place of business is 116 Pinellas Bayway, Tierra Verde, Florida 33715.

ARTICLE III Term of Existence

This corporation shall have perpetual existence.

ARTICLE IV Nature of Business

- A. The corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida, and any and all acts or statutes amendatory thereof supplemental thereto.
- B. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, and to engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- C. To do such other things as are incidental to the foregoing, or necessary or desirable in order to accomplish the foregoing.

ARTICLE V Capital Stock

The Maximum number of shares of stock the corporation is authorized to issue is 1000 shares of One Dollar (\$1.00) par common stock. Stock may be issued by the corporation from time to time for such consideration as may be fixed by the Board of Directors. Each share of common stock shall represent one (1) vote.

Upon dissolution or liquidation of the corporation, the holders of stock shall be entitled to distribution ratably as their holding may appear upon the stock record of the corporation.
