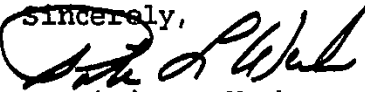

**ARTICLES OF INCORPORATION**

The undersigned subscriber to this Certificate of Incorporation hereby executes these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of the corporation shall be:

*PEOPLE LINK NETWORK, INC.*

**ARTICLE II**

**GENERAL NATURE OF BUSINESS:**

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation are:

To engage in any activity or business permitted under the laws of the United States and of this State.

**ARTICLE III**

**AUTHORIZED STOCK:**

The authorized capital stock of this corporation shall be *One Thousand (1000)* shares of common stock at the par value of (\$ 1.00) Dollar per share. All of said stock shall be payable in cash, property, labor or services, at a just valuation to be fixed by the stock holders at a meeting called for that purpose.

#### **ARTICLE IV**

This corporation shall have perpetual existence unless sooner dissolved according to law.

#### **ARTICLE V**

##### **DOMICILE:**

The initial post office address of the principal office of the corporation is *1437 S.E. 13th St., Deerfield Beach, FL 33441*. The stockholders may from time to time designate such other post office address and place for the principal office within the State of Florida of this corporation as they may see fit.

#### **ARTICLE VI**

##### **MANAGEMENT BY STOCKHOLDERS:**

These Articles of Incorporation provide that the business of the corporation shall be managed by the stockholders of the corporation rather than by a Board of Directors.

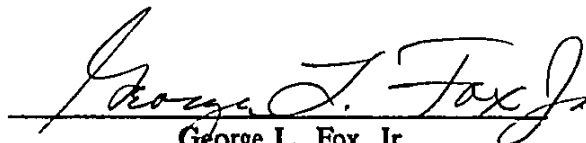
### AMENDMENT:

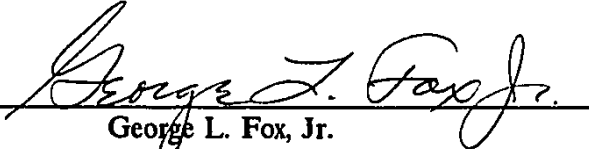
