**ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS**

The name of the Corporation shall be **TECHNO PRODUCTIONS INTERNATIONAL, INC.**. The principal and mailing address of the corporation shall be 401 E. Jackson Street, Suite 2400, Tampa, Florida 33602.

**ARTICLE II - CAPITAL STOCK**

The Corporation is authorized to issue one thousand (1,000) shares of capital stock of the par value of One Dollar (\$1.00) which shall be designated "Common Shares," and all of which shall have the same rights and privileges.

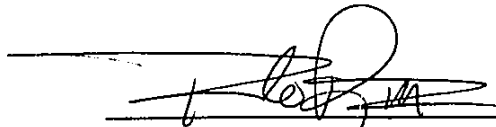

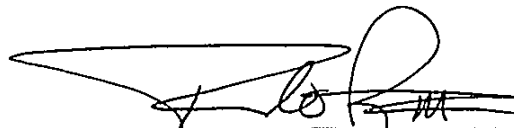
