ARTICLE I - NAME

The name of this Corporation is TREAT CENTERS USA OF PEMBROKE PINES, INC. and its address is 3990 Sheridan Street, Hollywood, FL 33021.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

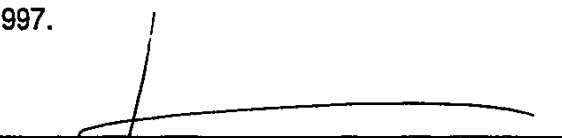
ARTICLE IX - INCORPORATOR
