The undersigned for the purpose of forming a corporation under the Florida Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is  
TRAVEL OPPORTUNITIES of S.W. FLORIDA INC.

ARTICLE TWO

The principle office of the corporation will be located at 1380 Homestead Rd. Lehigh Acres, Fl. 33936 or such other place, or places may be designated by the Board of Directors at some future date.

ARTICLE THREE

The duration of the corporation is perpetual, except that same may be dissolved, as provided by the law and pursuant to Section 607 of the Statutes of the State of Florida.

The general purpose for which the corporation is organized is:

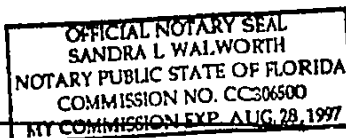

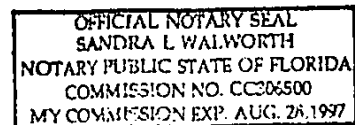
