# **ARTICLES OF INCORPORATION**

## JOAN I. NEUWIRTH, P.A.

### ARTICLE I

The name of this corporation is Joan I. Neuwirth, P.A. (hereafter the "Corporation"). The purpose of the business of the Corporation is to engage in the practice of law.

## ARTICLE II
