
Dear Sirs;

I wish to inquire as to whether there might be a waiver of late fees for filing after the initial deadline? We had a business until early this year and found the main employee was siphoning off funds for his personal use. We wound up around \$25,000 in the hole and still have not recovered from the theft. At the same time, in April, I was laid off from work and did not find another job until June. We have not been financially able to catch up with household bills and are struggling to cover this payment.

This was not trying to avoid the fees, just an inability to pay them at the time. If there were not a waiver available, what would the time frame be to pay the additional amount? I need to keep the corporation open, as it does bring in some funds, and is starting to grow again. The other corporation that was linked to this one, Pony Cars of Yesteryear, has been shut down permanently. There was just no way to continue both.
