

ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 60% the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

## ARTICLE I
