

ARTICLES OF INCORPORATION OF CASE & COMPANY, INC.

The undersigned, for the purpose of forming a corporation under the Fiorida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I NAME AND ADDRESS

The name of the corporation is Case & Company, Inc. The principal office of the corporation is Route 7 Box 953, Tallahassee, FL 32308. The mailing address of the corporation is Route 7 Box 953, Tallahassee, FL 32308.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The general purposes for which the corporation is organized are the following:
