##### INDEMNIFICATION





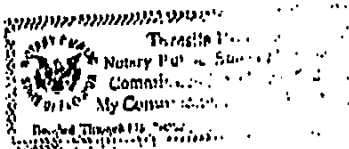
