ARTICLES OF INCORPORATION

OF

MARTIN-SHAFER, INC.



Article I - Name

The name of this corporation is Martin-Shafer, Inc. and its principal office is located at 109 Hedgegrove Ave., Satellite Beach, FL 32937.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.

Article III - Purpose
