

ARTICLES OF INCORPORATION OF THEME QUEST ENTERTAINMENT, INC.



The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Entertainment:

ARTICLE I

The name of the corporation is Theme Quest Entertainment, Inc.

238 North Westmonte Drive #107, Altamonte Springs, FL 32714

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The purpose of this corporation shall be to produce and direct entertainment events, primarily of a distinct theme or themes and produced aboard cruise or ship lines, and to do all things necessary or convenient to carrying out such purpose. This corporation may also engage in any business which may be legally transacted in Florida, and to do all things necessary or convenient to any such business.

ARTICLE IV

The aggregate number of shares which the corporation is authorized to issue is one thousand (1000), all common stock of a single class at no par value.

ARTICLE V

The street address of the initial registered office of the corporation is 238 North Westmonte Drive, Altamonte Springs, Florida, and the name of its initial registered agent at that address is Hal Katz.

ARTICLE VI

The initial board of directors shall consist of one (1)director. The initial director shall be Hal Katz, whose address is 238 North Westmonte Drive, Altamonte Springs, Florida. The number of directors on the board may be changed by the bylaws as enacted by the corporation, but shall never be less than one.

ARTICLE VII


