THE UNDERSIGNED, acting as sole incorporator of Global Impact Concepts, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be Global Impact Concepts, Inc., and the corporate address shall be 7724 Rollingridge Ct., Orlando, FL 32835.

ARTICLE III

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

The purpose of the corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.

ARTICLE IV

Shares

The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) consisting of a single class of common stock, with no par value.

ARTICLE V

Initial Registered Office and Agent

The address of the initial Registered Office of the corporation is 7724 Rollingridge Ct., Orlando FL 32835, and the initial Registered Agent at such address is Robert Glenn Reeder.

ARTICLE VI

Initial Board of Directors

The number of Directors constituting the initial Board of Directors of the corporation is one (1). The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than one (1). The names of the persons who are to serve as initial Directors until the first annual meeting of the shareholders of the corporation or until such successor Directors are elected and shall qualify are as follows:

Each shareholder of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation.


