### Articles of Merger

Pursuant to Section 607.1105, Florida Statutes, GCM Acquisition Scape Fall Proposation ("Gold Coast"); Gold Coast Media, Inc., a Florida corporation ("Gold Coast"); Coast to Coast Direct, Inc., a Florida corporation ("Coast to Coast"); BackEnd Inc., a Florida corporation ("BackEnd"): and Psychic Operators, Inc., a Florida corporation ("Psychic"), do hereby adopt the following Articles of Merger merging Gold Coast, Coast to Coast, BackEnd and Psychic (sometimes collectively referred to herein as the "Companies") into GCM.

## 1. The Merger.

Gold Coast, Coast to Coast, BackEnd and Psychic shall be merged with and into GCM pursuant to the Agreement and Plan of Merger entered into as of March 24, 1997, by and among the Buyer and the Companies (the "Merger Agreement"). The provisions of the plan of merger for the merger are as set forth in these Articles of Merger.

The Directors of GCM who are in office as of the Effective Time of the Merger shall remain the Directors of the Surviving Corporation, retaining their respective positions and terms of office.

### 8. Conversion of Shares.

Each of the outstanding shares of capital stock of the Companies shall be converted into the receive cash as described in the Merger Agreement.

# 9. Capital Stock of Surviving Corporation.

The shares of capital stock of the Surviving Corporation issued and outstanding immediately prior to the Effective Time of the Merger shall be unaffected by the Merger.

# 10. Shareholder and Director Approval

The Merger Agreement was duly approved by the shareholders of the Companies on the 7th day of April, 1997, and by the shareholders of the Surviving Corporation on the 7th day of April, 1997.


