

ARTICLE I. NAME

The name of the corporation shall be:

The principal place of business of this corporation shall be:

ARTICLE II. NATURE OF BUSINESS

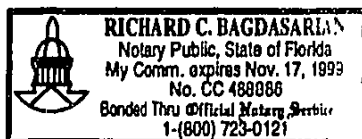


