### ARTICLES OF INCORPORATION

OF

The undersigned incorporator, being a natural person competent to contract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida. SFFECTIVE DATE

# **ARTICLE I**


