The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the laws of the State of Florida. efective date

# **ARTICLE I-NAME**

The name of the corporation shall be OLAMA MANAGEMENT, INC

# ARTICLE II-PRINCIPAL OFFICE

# ARTICLE III-DATE OF EXISTENCE
