**ARTICLE I - NAME**

The name of this corporation is SIGNS & GRAPHICS, INC.

**ARTICLE II - COMMENCEMENT OF EXISTENCE AND  
DURATION**

The date of commencement of the existence of the corporation shall be upon the filing of these Articles and the corporation shall exist perpetually.

corporation is: 140 Alexandria Blvd., Suite I, Oviedo, FL 32765. The corporation may, from time to time, change the principal office of the corporation or may designate such other offices and places of business as it deems necessary to carry out its purposes.

#### ARTICLE IV - PURPOSE

This corporation is organized for the purpose of designing, manufacturing and selling signs, neon logos, graphics, vinyl letters, posters, banners, van and truck lettering, window lettering, magnetic signs, and for any and all other lawful purposes.

#### ARTICLE V - CAPITAL STOCK

This corporation shall have one class of shares, designated as "common shares". The corporation shall indemnify any officer, director or incorporator, or any former officer, director or incorporator, to the fullest extent permitted by law.


### ARTICLE XII - AMENDMENT
