ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

L. A. FITNESS, INC.

1. The name of this corporation is L. A. FITNESS, INC. (the "Corporation").
2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

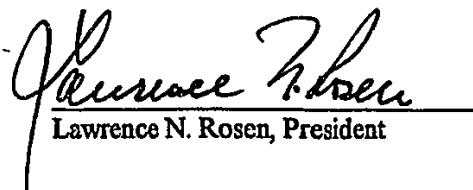
ARTICLE I - NAME
