ARTICLES OF INCORPORATION

Executed by the undersigned for the purposes of forming a Florida Corporation under Chapter 607, Florida Statues (1995):

ARTICLE I. NAME AND ADDRESS

The name and address of the corporation is:

ATLANTIC PROFESSIONAL EMPLOYERS, INC. 1734 Chalet Street Orange Park, Florida 32073

ARTICLE II. DURATION

This corporation shall exist perpetually and shall commence on the date of execution and acknowledgment of these Articles.

ARTICLE III. PURPOSES

This corporation is organized for the following purposes:

- 1. To establish, develop and promote an employee leasing business with its attendant benefits and services to employers in need of cost effective delivery of employee related benefits, required insurance coverages and governmental reproting compliance.
