The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is Orcam Design Corporation

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the corporation's principal office is Orcam Corporation, c/o Kluger, Peretz, Kaplan & Berlin, P.A., 1970 Miami Center, 201 So. ARTICLE III

DURATION AND COMMENCEMENT OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence upon the filing of these Articles of Incorporation with the Department of State.

NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business.
