**ARTICLE I  
NAME**

**ARTICLE III  
CORPORATE PURPOSE AND POWERS**

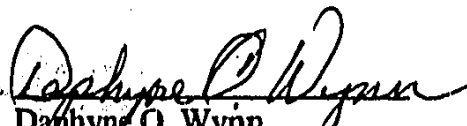

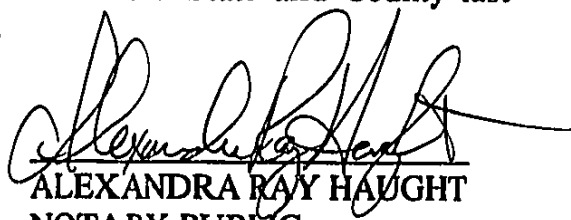
