ARTICLE I - NAME

The name of this Corporation is ACADIA MANAGEMENT SERVICES, INC. and its address is P. O. Box 52-6822, Miami, Florida 33152-6822.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 5,000 shares of one (\$.01) penny par value common stock, which shall be designated "Common Shares."

ARTICLE IX - PREEMPTIVE RIGHTS


